Committee & Board Updates

A brief update was provided by board and committee members on the work currently being done in the NWCoC to date in 2024. Highlights:

NWCoC Board: Policy and procedural changes and NOFO 2024 preparation.

REAP: Recent award of six grants to Anishinaabe Endaad, Bi-Cap, HRDC, Mahube-Otwa, Nameless Coalition and YESS for projects addressing culture and equity issues.

Youth Committee & Youth Action Board: Review and recommendations to the YHDP NOFO.

Coordinated Entry and CES User groups: Software transition and training. Housing First trainers will be attending upcoming Case Conferencing sessions.

Eccovia Update

An update was provided on the transition from Wellsky to Eccovia. Update included information from ICA on steps to transition, what to expect next and how best to prepare. In anticipation of the new end of July, 2024 Go Live date, ICA will be thoroughly and iteratively testing how the new system is developed so users can accurately collect data for their projects; thoroughly testing the data being

migrated; and preparing the community for differences in the end user experience, including more time to produce high quality training. A NWCoC-wide training will be provided on July 17th, from 1-4pm at Garden Valley Technologies in Erskine. This will be an interactive training led by ICA. 2024 NOFO

An update was provided for the 2024 NOFO along with an expected timeline for the local competition.
