Purpose Statement- 5 points	<u>1-2 Low Criteria:</u> The purpose statement is unclear and does not accurately describe the grant's purpose.	<u>3-4 Medium Criteria:</u> The purpose statement is written well but is missing key details needed to understand grant.	<u>5 High Criteria:</u> Purpose Statement is clear, concise, and accurately describes the purpose of the grant application, with an overview of project details.
Context- 20 points	<u>1-6 Low Criteria:</u> The applicant did not describe why grants are needed.	<u>7-13 Medium Criteria:</u> Context written well but missing key details to demonstrate need and understand gaps in services.	<u>14-20 High Criteria:</u> Applicant clearly demonstrates community needs and gaps in services.
Activities + Partnerships- 30 points	<u>1-10 Low Criteria:</u> Grantee did not demonstrate any activities or partnerships that will accomplish goals or address needs.	<u>10-20 Medium Criteria:</u> Key activities are missing details to understand how the grantee will complete work.	<u>20-30 High Criteria:</u> Grantee went above and beyond to describe the following: key partnerships activities that are within the scope of work and provided details of the timeline of grant activities as it relates to goals. Non-tribal organizations described a clear, concise plan to collaborate with local tribal programs.

Grantee demonstrated a clear plan for evaluating program outcomes and measuring success. Grantee accurately estimated the number of youth impacted by the project and included details on how this number will be tracked/reported.
